Key Responsibilities:

- Support and coordinate in time execution of equipment and process validations and qualifications, liaising with all the relevant parties at shop floor to ensure accurate execution.
- Coordinate and support process changes (PCC).
- Collect data for ongoing process verification (OPV), support product steward in tracking and evaluation of product performance and implementation of CAPAs.
- Perform first line evaluation of product and process related issues, perform root-cause investigations (uncritical, major and critical deviations, OOS, OOE) and implement effective CAPAs.
- Support technology trainings and education programs for production operators and others.
- Act as Subject Matter Expert for Audits.
